1. Call to Order & Roll Call

Mrs. Martin, Vice-President of the Board of Education, called the meeting to order at 6:00 PM in the Administration Building Board Room. At the beginning of the meeting, the chairperson announced and informed the public that a current copy of the Open Meetings Act was posted on the west wall of the meeting room and accessible to members of the public.

2. Approval of the Agenda

3. Title IX Policy

Mr. Alexander shared a redline version of the policy with Board members. He shared that there are more language type changes opposed to procedural type things.

4. Policy 6111 Classroom Environment

Board member Riedesel provided fellow Board members with a packet of information regarding this topic and explained his intentions moving forward. A short discussion ensued.

5. District Strategic Plan Update

Dr. Nielsen provided a summary of some of the most recent action as it pertains to the district's strategic plan. She highlighted the following:

- Strategy 1 Action Plan 1- the new PK-5 building is complete and move in occurred in August 2024
- Strategy 1 Action Plan 3- developing consistent technology practices across the district
- Strategy 2 Action Plan 3- promoting student and family wellness with the implementation of a school-based mental health counselor
- Strategy 3 Action Plan 1- updates made to the classified salary schedule to be more competitive with the local market
- Strategy 4 Action Plan 1- developing a CTE strategic plan and implementing a career fair at the middle school for 8th graders

6. Elementary Playground Expansion

Mr. Alexander shared that we need some additional structures for the K-5 playground area (west end of the new building). He shared that he is working with the rep from Cunningham to start getting a design and some projected costs for additional installation. Mr. Alexander believes this should be within the means of the depreciation account and the goal would be that this might be possible this fall.

7. 2024-2025 Budget Preview

Mr. Alexander presented historical information on student enrollment, state aid, valuations, tax levies, revenue and expenditures, and cost per pupil. He noted that valuations had been certified and included a 8% increase from the previous year. The district will see a bump in state aid due to the 2-year new school adjustment that we are eligible for. Mr. Alexander presented an estimated proposal for the tax levy and informed the Board that at this time it will not be necessary for the district to attend the joint public meeting.
