At the beginning of the meeting, the chairperson announced and informed the public that a current copy of the Open Meetings Act was posted on the west wall of the meeting room.

4. Outstanding Recognition

4.1. Employee of the Month

Mrs. Replogle recognized Ben Nies, custodian at Paddock Lane Elementary, as the December Employee of the Month. Those nominating Ben stated that he is very patient, kind, and reliable. He takes a ton of pride in his job and the building itself. One of the responsibilities that he also assists with is lunchroom duty. Due to the number of students at Paddock Lane, Ben often has to set up and take down presentations multiple times. Ben is a true team member and is always willing to jump in and take care of what ever needs to be done for the students and staff.

4.2. Business Friend of the Month

Mr. Alexander recognized Exmark as the December business friend of the month. He stated that Exmark has proven to be a terrific partner in education for many years. Recently, they donated a \$15,000 lawnmower to the

district. They were also one of the first businesses to step forward with a major donation to the House of Orange community building project. The most significant contribution Exmark makes is their participating in the valuable work experiences that they provide for our high school students. BHS students are able to experience work-based learning opportunities, job shadow experiences, and tours of the Exmark facility. Exmark has also partnered with N-Gage and the local schools to offer a learning opportunity through the Manufacturing Day.

4.3. Board Member Recognition- Erin Chadwick and Jon Zimmerman

Mr. Alexander recognized Board Members Erin Chadwick and Jon Zimmerman for their service to the Board of Education. He added that they both spent countless hours volunteering their time to be an integral part of supporting the district and putting students first. 5.1. Student Update

Riley Schwisow informed the Board that the breakfast with Santa event was a huge success with 419 people attending. Home visits for the preschool will start up again in January. Paddock Lane has been buzzing with holiday activities as staff and students are participating in theme days to count down the 12 school days until Christmas. NSCAS testing is wrapping up for 3rd-5th grade students and kindergarten- 2nd grade students are finishing MAPS testing. Lincoln and Stoddard students recently enjoyed the performances by the high school and middle school music groups. Students are also completing their testing this week as well. Beatrice Middle School conducted a service project and raised over \$700 for the Gage County Christmas Wish List. The boys basketball team placed 3rd at the TBC basketball tournament. As the semester ends, students are finishing up their winter benchmark tests. At the High School, Key Club is currently doing Santa to a Senior with the Homestead. The Student Council is hosting a door decorating contest along with Christmas Spirit Week. The winter sports are off to a great start as well. Finals testing will begin at the end of next week.

8.4. Approval of the superintendent contract addendum

Byars informed the Board that in September the negotiations committee requested a comparability study be done for the Superintendent as this has not been done during the past five years. Next, she shared the ranking results (total array of 10) indicated by the study. The negotiations committee recommended an 8.66% total compensation increase and the addition of a monthly cell phone allowance. These changes will result in Mr. Alexander ranking at the mid-point (5 of 10) within the array. Byars summarized additional factors that were taken into account.
