All proceedings of the Board of Education, except as may be hereinafter noted, were taken while the convened meeting was open to attendance of the public.

1. Call to Order & Roll Call

Mr. Trusty, President of the Board of Education, called the meeting to order at 7:00 PM. At the beginning of the meeting, the chairperson announced and informed the public that a current copy of the Open Meetings Act was posted on the west wall and accessible to members of the public.

2. Pledge of Allegiance

4. Outstanding Recognition

4.1. Employee of the Month

She manages the House System school store, serves as a 7th grade lifeguard (making daily contact with students on the ICU list), provides individual and small group instruction, and lastly provides behavioral support for students who need it.

4.2. Business Friend of the Month

Mr. Alexander recognized Uhl's Sporting Goods as the BPS Business Friend of the Month. He stated that Uhl's is a great community supporter who has consistently been there to help support the district with apparel (for sports teams and House system shirts) as well as financially. Mr. Alexander thanked Riley Schwisow for serving as the student rep for the Board of Education and informed her that the Board has a plaque as a token of appreciation. Mr. Alexander commended Riley for being a student of high character and wished her all the best with her future endeavors.

5. Information

5.1. Student Update

Riley Schwisow informed the Board that the preschool students recently attended kindergarten roundup activities and the family picnic is scheduled for Wednesday. The staff at Paddock Lane recently enjoyed lunch courtesy of the Board of Education and students are looking forward to walk the track events and end-of-the-year recognition days. Students at Lincoln and Stoddard are wrapping up the school year with field trips, a plant sale, skating parties, and recognition events also. At Beatrice Middle School, the track teams experienced success at the conference meet. The 8th grade students will be completing water testing at the Homestead soon and the House champion will be crowned on Friday. Senior honors night was held at the Hevelone Center last weekend and graduation is scheduled for Sunday, May 21st. The baseball team qualified for the state tournament and the final music concern is tonight.

5.2.2. Americanism

Mrs. Pieper reported that the committee met prior to tonight's regular meeting and confirmed the following:

- District's social studies curriculum is aligned with NDE standards
- District's social studies curriculum stresses the required patriotic themes
- In accordance with state law, that high school students complete a written test, attend a public meeting, or present or write a paper on an appropriate topic
- Curriculum approved by the Committee is available for public inspection
- District's social studies curriculum includes all required components which include one hour per week of
 patriotic instruction for grade levels below sixth grade, set amount of time to teach American history for
 grade levels from fifth grade to eighth grade, and at least two courses in high school that teach
 American civics
- District will conduct appropriate patriotic exercises for holidays (George Washington's birthday, Abraham Lincoln's birthday, Dr. Martin Luther King Jr.'s birthday, Native American Heritage Day, Constitution Day, Memorial Day, Veterans Day, and Thanksgiving Day)

5.2.3. STANCE Report

Mr. Alexander informed Board members that during the meeting on April 27th, Bryce Wilson, finance coordinator for the NDE, was able to join. He noted that the finance package is very complex and nothing will be solidified until the legislative session is over.

7.2. Discuss, consider, and take all necessary action with regard to possible approval and authorization to execute an agreement with the City of Beatrice for proposed public infrastructure improvements adjacent to the new PK-5 elementary site

Mr. Alexander expressed appreciation to the City of Beatrice for the proposal and the opportunity to create a working relationship for community improvement. He noted that the proposal addresses city improvements that will eventually need to be done, it promotes public safety in a school zone, and creates the certainty of improved traffic flow for parents and students at the new site. President Trusty summarized the proposal highlighting the improvements that will be made as well as how the funding will be split. The city will provide the upfront funding for the project with BPS reimbursing for their share (40%).

I move that the Board of Education of District #15 hereby approves the agreement with the City of Beatrice, Nebraska, relating to the design, construction, and reimbursement of a portion of the costs for certain public infrastructure improvements adjacent to the new PK-5 elementary school facility being constructed near 33rd and Lincoln streets, such agreement in the form on file with official school district records and as presented at this meeting or with such changes as are deemed necessary and in the best interest of the school district and approved by the Board President or Superintendent of Schools, and further hereby authorizes the Board President to sign, execute and deliver such agreement, and further hereby authorizes the Superintendent of Schools to pay all costs and expenses required or provided for under such agreement passed with a motion by Doris Martin and a second by Eric Book.
